- The accounts of the College shall be audited by a Chartered 11. Accountant and be open for inspection by the AICTE or anybody authorised by It.
- di er e postro e e e e e A duly registered undertaking on non-judicial stamp paper 9. must be Submitted by the end of December, 1993 for fulfilment of the general conditions.
- The College shall follow strictly any further conditions as 1(). may be laid down by the AICTE from time to time.

This approval is also subject to full compliance with SCHERE as prescribed by the Supreme Court In its Judgement dated 4.2.1993 con MPCC: No.607 of 1992 with other MPsolim the case of Unnikrishnan, J.P. and others etc. etc. evs (State of Andhra Pradesh and others etc. etc. and the related guidelines and criteria as may be issued by the AICTE or the Central Government from thue to time.
